VOTER QUALIFICATIONS

- Must be a United States citizen
- Must be a resident of the Whitehall Central School District a minimum of 30 days prior to the vote date
- Must be 18 years of age

ABSENTEE BALLOTS & EARLY MAIL BALLOTS

A completed application must be received by the District Clerk no earlier than thirty (30) days before the vote, and no later than seven (7) days before the vote if the ballot is to be mailed to the voter, or the day before the vote if the ballot is to be delivered personally to the voter. The ballot must be returned to the District Clerk no later than 5:00 p.m. on voting day.

On Tuesday, February 6, 2024, the Whitehall Board of Education (BOE) will seek voter approval of a proposed capital project unanimously recommended by the BOE. The project focuses on repurposing space in the Jr./Sr. High School, which will provide our students with the education and skills necessary to be competitive in their various future endeavors.

The BOE and school administrators, in collaboration with district architects Tetra Tech Architects, and the financial consultants of Bernard P. Donegan, Inc., explored several options. Serving our students and being fiscally responsible to our community were the top priorities. They concluded repurposing the natatorium would provide the much needed learning space the building currently lacks. Additionally, repurposing the space would serve the greatest number of students, with zero tax increase to the local share, meaning no increases to taxpayers.

The project total is estimated at \$9,025,000. It will be funded by utilizing \$2,600,000 from the capital reserve fund. Since the project is not new construction, and does not change the blueprint of the building, the remaining balance of \$6,425,000 is eligible to receive NYS Building Aid.



WHY MORE LEARNING SPACE IS NEEDED

Although student enrollment has decreased, regulations to the following have changed:

NYS Education graduation requirements have increased per NYS Education Law.

Regulations to support learning, privacy, and confidentiality have increased per NYS Education Law. Schools now provide many services traditionally located elsewhere, such as mental health services and other social issues.

NYS Graduation Requirements Have Changed, But Our Building Has Not

Local high school diplomas no longer exist. NYS Education requires that all students earn a NYS Regents diploma. This went into effect beginning the 2009 school year, with the first cohort of students under this mandate graduating in 2012.

We Offer An Education Beyond NYS Graduation Requirements

We are proud to offer an education above and beyond the minimum requirements by providing our students:

- Classes to earn a NYS Advanced Diploma
- Classes to earn a NYS Mastery Diploma
- Classes to earn up to 21 college credits upon graduating from high school

In order to offer these opportunities, classes beyond the required minimum number of required credits to graduate were added. However, in the building's current situation, the classroom space is still the blueprint to accommodate a curriculum in which students only needed to earn the minimum 22 credits.

WHY MORE LEARNING SPACE IS NEEDED

Special Education Regulations Have Changed, But Our Building Has Not

There is not a dedicated resource room to provide special education. To meet the NYS Education law requirements:

- 13 Resource Rooms are needed daily
- 11 Academic Intervention Services (AIS) rooms are needed daily

The Role Of Schools Has Changed

Schools now serve as the hub for the much needed social and emotional services not available in our immediate community. These student services require private and confidential space and currently there is none. Without providing these services on-site, our students would miss valuable classroom time to travel to and from appointments, or worse - not receive the services at all.

QUESTIONS & ANSWERS

How Has The District Been Able To Provide These Educational Opportunities & Services Without The Space?

- In addition to their regular responsibilities, every semester our school administrators dedicate a great deal of time to logistically determine which classrooms each course will be taught in
- In the building's current situation, 12 out of 15 of our high school teachers must vacate and turn over their classrooms throughout the day multiple times in order to create space for special education classes and other student services
- The only reason three of the 15 teachers do not have to turn over their classrooms to other teachers is because they are lab science rooms

How Will This Project Be Funded With No Increase To Taxpayers?

The project total is estimated at \$9,025,000. It will be funded by utilizing \$2,600,000 from the capital reserve fund. Since the project is not new construction, and does not change the blueprint of the building, the remaining balance of \$6,425,000 is eligible to receive NYS Building Aid.

Is There A Plan For Students Who Want To Swim?

Yes. The BOE and school administrators recognize the importance of providing students the opportunity to learn and practice swimming. In partnership with Castleton State College and Hudson Falls Central School District, our students may attend these swimming programs with transportation provided at no cost to students or their families.

Did The BOE Explore Other Options?

Yes. Refurbishing the natatoriam was explored. The cost is estimated at \$13,625,000. The full \$2,600,000 in the Capital Reserve would be available for funding. However, only \$8,672,966 of the project would be eligible for NYS Building Aid; leaving a balance of \$2,352,034 to be paid by the local taxpayers.

Additionally, there is projected annual expense of \$70,000 to properly maintain the pool per NYS Codes & Regulations. This includes heat, lights, chemicals, daily water testing 3 times per day 365 days per year. This expense would impact the annual school budget.



WHAT IS ON THE BALLOT? PROPOSITION #1

SHALL the Board of Education of the School District be authorized to (1) reconstruct, renovate and improve various School District buildings, facilities and sites, acquire original furnishings, equipment, machinery or apparatus required for the purpose for which such buildings, facilities and sites are used and pay incidental costs related thereto, at a maximum cost of \$(9,025,000), (2) expend such sum for such purpose, including the expenditure of \$2,600,000 from the Capital Reserve Fund; (3) levy the necessary tax therefore, taking into account state aid, to be levied and collected in annual installments in such years and in such amounts as may be determined by the Board of Education taking into account state aid received and the expenditure from the Capital Reserve Fund; and (4) in anticipation of the collection of such tax, issue bonds and notes of the School District at one time or from time to time in the principle amount not to exceed \$(6,425,000), and levy a tax to pay the interest on said obligations when due.
